DEFINITIONS

1. **"Employee"** means Port Authority of Thailand (PAT) employee.
2. **"Port"** means Laem Chabang Port (LCP).
3. **"Day"** means period of time starting from 0.00 hour until 24.00 hours of each day unless specified otherwise
4. **"Month"** means calendar. month starting from the 1st. day of the month until the end of each month.
5. **"Vessel"** means cargo vessel or other sea going vessel unless specified otherwise.
6. **"GRT"** (Gross Registered Tonnage) means gross registered tonnage of vessel or barge which has been registered at the original port of registration.
7. **"Tonne"** means revenue tonne which is equal to the bigger figure of the weight in metrictonne and of the volume in cubic meter. Revenue tonne is the basis for calculating the port charges.
8. **"Port Area"** means the area as specified in the Royal Decree defining the limits of PAT's jurisdictional area at Laem Chabang Port, (LCP).
9. **"Berthing Area"** means any berthing place within the Port Area under supervision of LCP as follows:
 - **"Berth"** means berthing place of Multipurpose, Container, Coastal, Service or Bulk terminals.
 - **"Anchor Area"** means anchor area which is permitted within the Port Area.
10. **"Custom Area"** means specified custom area at Berth.
11. **"Private Wharf"** means the wharf under supervision of a private or State Enterprise (not PAT) which is in the Port Area.
12. **"Consignee or Consignor"** means owner of import or export cargo or other person who is in charge of that cargo for any period of time since receiving from or delivery to Shipowner or its Agent.
13. **"Storage Area"** means area for storing cargo on open yard or inside CFS or warehouse within Custom Area.
14. **"Valuable Cargo"** means any cargo with a value per package, per piece, per one cubic meter or per 250 kilograms of more than 25,000 Baht and of which the owner intends to hold the Port responsible for the value of that cargo by notifying the Port in writing before receiving the cargo into the Port.
15. **"FCL"** (Full Container Load) means loaded container which is not stuffed or unstuffed inside the Custom Area.
16. **"LCL"** (Less Than Container Load) means loaded container which is stuffed or unstuffed inside the Custom Area.
17. **"Oversized Container"** (Overheight/Overwidth/Overlength Container) means a container that contains cargo beyond the limits of its size.
18. **"Through Cargo or Shifting Container"** means cargo or container that has origin and destination at another port and has been unloaded on to the terminal or barge at the Berth and has been loaded back to the same vessel for transportation to the destination port. Through cargo includes the equipment of the vessel, hatch covers, etc... brought on to the terminal. Such cargo or container shall not be handled in any way but temporary storage on the terminal.
19. **"Transshipment Cargo or Transshipment Container"** means cargo or container that has the same handling as Through Cargo or Shifting Container but has been loaded back to another vessel.
20. **In calculating the port charges, service charges, and other fees** that are charged per tonne, per day or per hour, any fraction of tonne, day or hour shall be counted respectively as 1 tonne, 1 day or 1 hour unless specified otherwise.

SECTION 1:

CHARGES AGAINST SHIPOWNERS OR SHIP'S AGENTS

101. PORT DUES

Use of channel, navigation aids, and other facilities to ensure safety in entering and leaving Port Area including cost for use of line handling boat and line handling services to/from Berth for vessels larger than 700 GRT.

Rates for 1 trip will be charged when entering port as follows:

	<u>Baht/GRT</u>
101.1 Vessel at Private Wharf or at Anchor Area which do not berth at LCP Wharf	0.5
101.2 Vessel at Berth	
102.2.1 Vessel From 700 - 2,000 GRT	3.0
102.2.2 Vessel over 2,000 GRT	6.0

Vessel making more than 1 trip per day will be charged for 1 trip only.

Any vessel using the channel more than 10 times per month will be charged 50% of the normal rate for their next trips in the same month. In case of more than 1 trip per day, this will count for 1 trip only.

In case of annual payment, registration and advance payment of 120 trips of the normal rate must be charged.

Vessels from the Thai Government and Foreign Warships will be exempted from these charges.

102. TUG SERVICE

Use of tug boat for servicing vessel. Charges are made according to the size of vessel per hour as follows:

102.1 Per tug boat less than 1,500 HP	0.2
102.2 Per tug boat more than 1,500 HP	0.4
	<u>Baht/Hour/Tug</u>
102.3 Minimum rate for tug boat less than 1,500 HP	2,500
102.4 Minimum rate for tug boat more than 1,500 HP	5,000

The period commencing when the tug boat clears her berth and ending when the tug boat is back at her berth.

In case of using tug boat for stranded vessel, assisting vessel in abnormal condition, or freeing ship's anchor or providing other services within the port area, the charges will be twice the normal charges.

At least 3 hours notice must be given to postpone or cancel tug service, otherwise vessel will be charged for a minimum service charge of 1 hour.

Tug services outside the Port Area will be considered case by case.

103. BERTH HIRE

Use of Berth for vessel. Charges are made according to berthing place and calculated per hour as follows:

104. BERTH HIRE OF OTHER CRAFT

Use of Berth for other types of craft. Charges are calculated per day commencing from the hour of berthing as follows:

105. GENERAL CARGO WHARFAGE

Use of Berthing Area and labour for stevedoring general cargo to or from vessel. The charges also include moving cargo to or from yard.

Cargo wharfage at Anchor Area does not include labour for stevedoring.

In case of storage at Storage Area, exemption period is 15 days after the completion date of unloading from vessel. If the cargo however has not been loaded to vessel during the allowed exemption period, the rule of Item No.204.1 will be applicable to that cargo relative to the

exemption period (which will be reduced to 3 days or 1 day, as applicable) and relative to the charges.

106. GARBAGE CHARGES

For garbage collecting services from all vessels. Charges are calculated per day commencing from the hour of berthing as follows:

Other vessels may request garbage collecting services, charges are made at the same rate as mentioned.

107. TELEPHONE SERVICE ON BOARD

Use of telephone on board of vessel at Berth for communications inside the Port on request of Shipowner or Agent.

Charges are per day 300 Baht/Phone/Day

In case of use of telephone for communications outside the Port, additional charges will be at the same rate as by the Telephone Authority of Thailand.

108. WATER SUPPLY SERVICES

Charges are 25 Baht/Cubic Meter

Minimum charge of fresh water supply is 50 cubic meter.

109. LABOUR STAND BY CHARGE

Charges for waiting time in case of Shipowner or Agent gave notice for loading/unloading general cargo or containers or for stuffing/unstuffing loose LCL cargo and operation cannot be continued for more than 1 hour for any reason and which is not the responsibility of the Port.

Charges are 2,000 Baht/Event

110. PASSENGER FEE

Fee for passenger entering or leaving at Berthing Area

Charges are 39 Baht/Person/Passage

111. QUAY CLEANING CHARGE

Charges for cleaning Berth which are calculated per day commencing from the hour of berthing.

Charges are 300 Baht/Vessel/Day

204. CARGO STORAGE

204.1 Import Cargo

For Storage of general cargo at Storage Area, exemption period is 3 days after the completion date of unloading from vessel.

In case of dangerous cargo, explosive cargo or flammable cargo with flash point at 61°C or 141°F or lower, exemption period is 1 day only after their unloading date from vessel.

In case of loose LCL cargo, charges are made from the day after container unstuffing, except the LCL is in the exemption period as stated in Item NO. 310.1.1



204.5 **Export Cargo**

For storage of general cargo which has not been loaded to vessel or stuffed into LCL, exemption period is 3 days after the day of passing through Custom Area by land or water,

After the exemption period, charges are 5 Baht/Tonne/Day
